For many years I have attempted to clear up my tax problems. In 2005 I paid *JK Harris* over \$5000 to handle them. **I am attempting to recover the \$5000. If successful, I intend to pay it to IRS. Related correspondence with JK Harris is attached.** They accomplished nothing – each year a new person was assigned to my account. They sent me a letter stating that JK Harris had not received necessary documents from me and would do no work until they did. Each year, until 2009 when I gave up on them, I sent the same papers again. I subsequently engaged Marvin Benson, an attorney in Vancouver WA, to do my 2002 taxes. He completed the return, **but I was neither able to pay him the remainder of his fee nor pay the money owed for the 2002 return because of financial problems:**

From October 2008 to the present I have faced insurmountable financial hardship, and suffered months of depression. On October 24, 2008, BAE Systems fraudulently terminated my contract over two months early. **This rendered me unable to pay the remainder of my 2007 and 2008 taxes as I had done for 2005 and 2006. BAE Systems continues to avoid paying me. If and when I get monies from them, I intend to pay it to IRS. Information regarding BAE Systems is attached.**

In early 2009 Social Security froze all of my accounts - they said that I had died in July 2008. **This added significantly to my financial chaos. Eventually my Social Security payments resumed,** but many financial scars remained. **Related information is attached.**

I had a plan B - as detailed in my Divorce Decree, \$20000 was to be paid to me on the sale or transfer of my ex-wife's home in Orlando FL. My son succeeded in a scam which left me unable to ever receive this money. **Related information is attached.**

Much of my hardship and declining health has been caused by my son's actions. He has stolen/embezzled tens of thousands from me. He tried to take my home from me as well. **On November 1, 2009 my wife went to San Jose, CA to take on three caregiver jobs in order to supplement our income in the hope of saving our home in Woodland, WA from foreclosure.**

Living alone, apart from my wife, caused further depression. On or near January 18, 2010, I received information from CHASE Bank regarding more devious actions to take my home, by my son and his partner. Anger overwhelmed me, **I checked my blood pressure; it had shot up to 188/98. I feared that I would die of a stroke. I visited my doctor the next morning. My blood pressure had increased to 192/110! Doctor prescribed additional medication for hypertension and suggested getting away from the source of my aggravation for a while.**

I visited my wife in San Jose. It was so good to be together again. We hugged each other and cried together when we met at the airport. But although the visit was over all too soon, its effect was positive - when I returned to WA, my blood pressure was 123/78.

I continued to do all possible to get a loan modification but never felt any progress. I called CHASE Bank many times a day and submitted paperwork over and over. Typically whoever I talked with seemed to have no knowledge of any of these preceding calls or paperwork. In early March 2010, on ABC World News with Dianne Sawyer, I saw an interview with an executive of a major bank, which I feel was CHASE. Basically, it went as follows:

ABC: "What do you do when someone calls asking for loan modification?"

Bank: "We give them an 800 number."

ABC: "What happens when they call it?"

Bank: "We give them the runaround."

ABC: "How many loan modifications have you finished?"

Bank: "Completely?"

ABC: "Yes."

Bank: "None."

I talked with several local realtors and found that banks overwhelmingly prefer foreclosure, it being more beneficial to their shareholders. Surprisingly, banks receive government money for foreclosures, further motivating them to ignore requests for loan modification!

In February 2009, I engaged an attorney in Orlando Florida to investigate why I had not received \$20000 and personal property declared in my Divorce Decree. Knowing of my financial situation, she worked on my case without charge. **She found that I had lost all further rights to the money or my personal property. My son scammed them from me by renegeing on a case which I had funded. He had promised to complete the case with full knowledge that not doing so would cause insurmountable problems with money owed and promised to the IRS. He waited until the last minute to inform me of his action and shortly thereafter the Statute of Limitations was exceeded. More is available in the attachments.**

On March 26, 2010 I left my home in WA as foreclosure was imminent and I was very ill. I am now living with my wife. At first it felt so good being away from the environment in which I suffered. But now, due to increasing tax worries, I am stressed again; my health suffers accordingly.

Recently, tax fears, caused my wife's health to suffer too. Her blood pressure is up 20%. Both of us had suffered mild strokes as a result of devastating stress caused by the actions of my son and BAE Systems. As a result of her stroke, a tumor was uncovered on her brain. So far, she has avoided surgery as she has been symptom free. Recently however, she experienced double vision followed by momentary blindness. She also has severe headaches in the area of her tumor. Her doctor had informed her that stress would cause such symptoms. I am very afraid for her and desperately want to relieve her of these fears.

She has nothing to do with what has happened with our 2007 and 2008 taxes. All she did was sign the returns, prepared by my CPA, as she had done per my request in 2005 and 2006. Arriving from Russia in 2005 and speaking little English, she totally depended on my direction. My fraudulent contract termination with BAE Systems and their continued effort to avoid paying me is the root cause for these problems. My wife has nothing to do with these events. PLEASE END HER SUFFERING, SEPARATE HER FROM MY TAX PROBLEMS!

I desperately need to resolve these problems as soon as possible. Every day, I witness the decrease in my ability to make decisions, the decline of my health, and my increased fear and depression. Further delay at arriving at a solution will serve no one. Please help me come to an agreement with IRS now, while I am still able. This has gone on for so long, I am tired, and I am tired of being tired.

The enclosed attachments explain my current financial hardship in increasing levels of detail. I apologize for the amount of documentation, but feel it is important for IRS to be familiar with my entire financial situation to enable a fair resolution.
